Though the order has stipulated interim tariff from the end of ten years of wind farm commissioning, the DL has accepted the invoices of the Company till December, 2010 and remitted full sale value of wind power sold to them. Further adjustments, if any, would be carried out on the basis of final order of the Commission / Tribunal / Courts.
- 3 As the Company has only one reportable segment, segment reporting as per Accounting Standard is not applicable.
- 4 Previous Year's / Period's figures have been regrouped wherever necessary.
